I. ASIA

a. COMUSMACV IS PREPARING TO FURNISH 48 AR-15 RIFLES TO U. S. MARINE CORPS HELICOPTER CREWS. NO U. S. ARMY UNITS WILL BE EQUIPPED WITH THE WEAPON. IT HAS BEEN DIRECTED THAT THE EVALUATION OF THE AR-15 USED BY MARINE HELO CREWS BE PERFORMED BY THE JOINT OPERATIONS EVALUATION GROUP (JOEG-V).

COMUSMAC-V HAS REQUESTED AND RECEIVED APPROVAL FROM OSD FOR ISSUANCE OF THE RIFLES, AMMUNITION AND NECESSARY RDT&E SUPPORT.

a. CINCLANTFLT HAS ISSUED HIS PLANNING DIRECTIVE FOR SOLANT AMITY IV. CG FMFLANT IS TO PROVIDE 30-40 MARINES FOR CEREMONIAL AND TRAINING PURPOSES, DRILL TEAM, AND ATHLETIC DEMONSTRATIONS. THIS FORCE TO BE EMPLOYED FOR NON-COMBAT EVACUATION DUTIES IF REQUIRED. 4 MARINES ARE ALSO TO BE PROVIDED TO ASSIST IN BEACH RECONNAISSANCE.
